## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (hereinafter called as the 'MoU') is signed on 1<sup>st</sup> day of April, 2022 by and between

**Sibsagar College, Joysagar, Sivasagar, Assam**, represented herein by its Principal and Secretary, Dr Profulla Chandra Kalita

and

**Swahid Peoli Phukan College, Namti, Sivasagar**, represented herein by its Principal and Secretary, Dr. Dhruvajyoti Nath.

### **Introduction:**

Envisioning prospective mutual benefits to be gained through a kind of academic collaboration and exchange for promoting research and academic activities through mutual understanding, the **Sibsagar College, Joysagar**, a provincialized autonomous college of Assam under University Grants Commission (UGC) and affiliated to Dibrugarh University, Assam henceforth enters into an understanding with **Swahid Peoli Phukan College, Namti, Sivasagar**, a provincialized college of Assam under University Grants Commission (UGC) and affiliated to Dibrugarh University, Assam.

### **Objectives:**

Under this MoU both the colleges have the following common objectives:

1. to undertake joint ventures in research and other academic and cultural exercises such as Short Term Courses, Seminars, Webinars, Workshops, Conferences, Internships and Cultural Activities.
2. to undertake initiatives for joint publication in the form of Journal, Books, etc.
3. to enhance global academic knowledge and exposure, both the institutes may exchange their Faculty Members and students to visit each other's institute for participating in Academic/Training Programmes.

### **Terms and conditions:**

1. The days or period of exchange programme shall be decided by the institutes mutually.
2. The host institute will provide food and accommodation to the participants during the days of their course. However, the host institute may charge a mutually agreed nominal fee against each participant during the course period.
3. The host Institute should receive participants' applications and all supporting documents or the proposal of the collaborative programme from the home institute at least three months prior to their expected date of the commencement of the programme.
4. No activity will be undertaken under this MoU by the institutes that may threaten our national security.
5. Selected exchange participants shall abide by all applicable rules and regulations of the home and host institutes. Each institution reserves the right to dismiss any participant/s at any time for academic or personal misconduct in violation of its established regulations. The dismissal of a participant shall not abrogate the arrangement regarding other participants.

### Validity of Agreement:

1. This agreement shall take effect on the date that it is signed and shall be valid for a period of five years. All modifications to this agreement must be in writing and signed by both the parties.
2. This agreement may be renewed or terminated by mutual consent expressed in writing. A minimum period of six months notice will be required from either party wishing to terminate the agreement.

### Coordination Committee:




