**Report of the Anti-Ragging Committee**

The Anti-Ragging Committee of SPP College is the Statuary/regulatory body that implements the guidelines in matters of planning actions for building and preserving a Culture of Ragging Free Environment in the college Campus. As per the notification in regard to prevention and prohibition of ragging in the college and UGC act, an Anti-Ragging committee has been constituted to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in unfair means or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension. Thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, to all students. To achieve these objectives the committee has been constituted.



**Forms of Ragging:**

Display of noisy, disorderly conduct, teasing, excitement by rough or rude treatment or handling, including rowdy, undisciplined activities which cause or likely to cause annoyance, undue hardship, physical or psychological harm or raise apprehensive fear in a fresher, or asking the students to do any act or perform something which such a student will not do in the ordinary course and which causes him/her shame or embarrassment or danger to his/her life etc.

**Punishment for Participation in/or Abetment of Ragging**

Following Punishment may be given to the learners for Participation in/or Abetment Of Ragging:

- Cancellation of admission from the college.
- Suspension from attending lectures and practicals.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any Internal /semester end examination or other evaluation process.
- Withholding results of Internal /semester end examination of the college.
- Debarring from representing the college in any national or international meet, tournament, youth festival, etc.

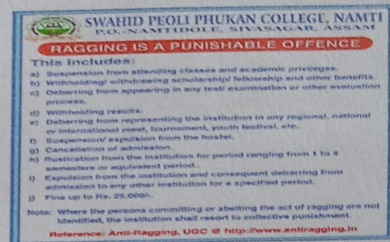
- Suspension/expulsion from the college hostel.
- Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period.
- Expulsion from the college and consequent debarring from admission to any other college/institution.
- Fine up to Rs. 25,000/-

The Anti-Ragging Committee has uploaded a portal in the college website and the authority has installed Complain Box in the campus for submission of online/offline students' grievances.
